Alpha track Radon Detector Instructions

A. Timing Guidelines

This alpha track radon detector can be used for test periods from 8 days to one year. Radon levels, like temperature, vary day to day and season to season, and in response to weather conditions and ventilation patterns. The longer you test, the more closely your result will represent the true average radon concentration.

B. Placement Guidelines

Radon concentrations can vary with location in a building. Radon usually enters a building from the soil underneath the basement or foundation, and radon concentrations are usually highest in the lowest level of a building.

The US EPA recommends that "The test kit should be placed in the lowest lived-in level of the home (for example, the basement if it is frequently used, otherwise the first floor)." It should be put in a room that is used regularly, a living room, playroom, den or bedroom, but not a kitchen, bathroom, laundry room, furnace room or a closet, stairway, hallway or crawl space. Place the kit in the breathing zone, at least 20 inches above the floor, in a location where it won't be disturbed, away from floor drains, drafts, appliances that are heat sources, and exterior walls, windows and doors.

C. Starting Your Test

- Open the protective pouch and remove the radon detector.
 Discard the pouch. If your detector rattles or if the top or bottom label is torn, do not use the detector. Call the RSSI radon laboratory at 800-762-7774 for a replacement.
- Write the start date on the top label.
- If you plan to hang the detector, firmly slide the hook into the groove on the bottom of the detector.
- Save the box, hook, information form, return postage label, and these instructions.
- 5. Do not disturb the detector during the test period.

D. Ending Your Test

- 1. Write the end date on the detector.
- 2. Fill out the information form
- Do <u>not</u> attempt to reseal the detector or place anything over the filter opening.

E. Return Detector to RSSI

- If the test is 8-14 days, your detector must be returned to RSSI's lab by overnight service to minimize exposure during transit.
- Place the data form, detector and hook in the box. Close the lid by tucking the flap in the box.
- If the test was 15 days or longer, apply the self adhesive return label, aligning the dotted line along the edge where the flap is tucked into the box.
- 4. Return the detector promptly after the test. If you use the prepaid, non-trackable return label, please allow up to 2 weeks for delivery to RSSI. If you want faster shipping and the ability to track your package, ship the detector by USPS, FedEx or UPS.

F. Obtaining Your Results

- Your Alpha-track detector will usually be analyzed within ten business days of its arrival at the laboratory.
- 2. Results will be available on-line at www.rssi.us/results.php.
- 3. A report will be mailed or emailed to you, depending on the option selected on the data form.

No charge will be made for replacement of inwarranty detectors when these instructions are followed.
